

Hubbard Radio Phoenix: "Desert Diamond Casino West Valley Basketball Blitz"
Sweepstakes – Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. Eligibility: The Desert Diamond Casino West Valley Basketball Blitz Sweepstakes (the "Sweepstakes") is open only to individuals who are at the time of entry are at least eighteen (18) years old and: (i) a permanent resident of Arizona; (ii) currently stationed at a military installation in Arizona; or (iii) a valid full-time student registered to attend on campus at a college, university or educational institution within the State of Arizona. Void outside of Arizona, and where prohibited by law. No purchase is necessary to enter the Sweepstakes. 2. When to Enter: The Sweepstakes from March 23, 2021, at 12:00:00 AM Pacific Time ("PT"), through March 27, 2021 at 10:00:00 AM PT ("Sweepstakes Period").

2. How to Enter: To enter, visit www.kdus1060.com/basketballblitz, www.kslx.com/basketballblitz, or www.98kupd.com/basketballblitz, find the Sweepstakes mention, then find, complete and submit the online entry form, which includes selecting the team you think will win the championship in the 2021 NCAA Men's College Basketball Tournament, you will receive a chance to have one (1) entry into the Sweepstakes random drawing. All guesses must be submitted by 10:00:00 AM PT on March 27, 2021 to be eligible for a chance to be included in the random drawing. **Limit: one (1) entry per person** during the entire Sweepstakes Period, regardless of the method of entry. Anyone attempting to get more than one (1) may be disqualified from the entire Sweepstakes at Sponsor's sole discretion.

3. Random Drawing: One (1) Grand Prize winner will be selected via a random drawing that will be conducted on or about April 5, 2021, from among all eligible entries who correctly guessed the winning championship team of the 2021 NCAA Men's College Basketball Tournament. **ONLY ENTRIES THAT CONTAINED THE CORRECT WINNING TEAM WILL BE INCLUDED IN THE RANDOM DRAWING.** Sponsor will conduct the random drawing. Decisions of Sponsor are final and binding. Odds of winning depend on the number of

entries that included the correct guess were received during the Sweepstakes Period. Grand Prize winner will be notified by email the Entrant used to enter on or about the date of the applicable random drawing. Each potential Grand Prize winner must reply to the email winner notification within **24 hours** or he or she will forfeit their right to the Grand Prize, and an alternate Grand Prize winner will be selected, time permitting.

4. Prize and Approximate Retail Value ("ARV"): One (1) Grand Prize - \$2,000.00, awarded in the form of a check to the winner. ARV: \$2,000.00. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner.
